

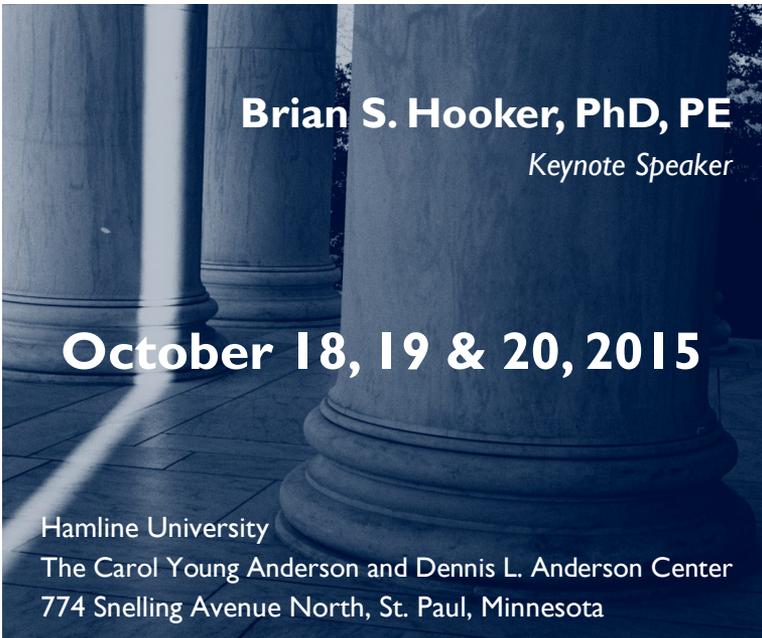

Her current obsession, which had a one year anniversary in August with #CDCwhistleblower, is harnessing the power of social media to create momentum in social change.

## STORIES OF FREEDOM, STORIES OF COURAGE

### **Health Freedom Story of Applied Action**

**Camilla Rees and Leo Cashman:** Putting into practice the challenge of protecting ourselves from the potential harm of EMFs is the specialty area of Camilla Rees, Founder of [ElectromagneticHealth.org](http://ElectromagneticHealth.org), Campaign for Radiation Free Schools, Co-founder of the International EMF Alliance, Advisor to the International Institute for Building Biology & Ecology, EMF Advisor to [Mercola.com](http://Mercola.com) and co-author of "Public Health SOS: The Shadow Side of the Wireless Revolution." Camilla and colleague Leo Cashman will provide a digital demonstration and brief explanation of WiFi concerns and the WiFi levels in the Congress meeting room and the reason why they have successfully negotiated with Hamline University to turn the WiFi off in order to protect our attendees during our Congress meetings.

### **Health Freedom Story of Courage**

**Atina Diffley:** Atina is an organic farmer-educator, activist, and author of the 2013 Minnesota Book Award winner, *Turn Here Sweet Corn: Organic Farming Works*—a memoir based on Atina's life running the Gardens of Eagan organic vegetable farm. Her advocacy has addressed the pressures of suburban development, and she successfully led a legal and citizen campaign against the notorious polluters, Koch Industries, to create an Organic Mitigation Plan for organic farms in Minnesota.

### **Health Freedom Story of Courage**

**Tami Goldstein:** At the age of thirteen doctors recommended institutionalization of Tami Goldstein's daughter Heather. Heather was vaccine-injured into medical and mental health decline. Tami Goldstein will share her daughter's journey through autism to functioning recovery. The obstacles faced were unimaginable. Tami holds that Autism/vaccine injury is a national epidemic and this is an example of what families with children with autism experience.

*Stories of Freedom, Stories of Courage* celebrate those who stand up, while also inspiring those working toward freedom, strengthening relationships, and encouraging collaboration.

Keynote Speech with Brian S. Hooker, PhD, PE

### **“Navigating the Dangerous World of Vaccine Safety”**



Brian S. Hooker, PhD, PE, is Associate Professor of Biology and Division Chair of the Science and Mathematics Division at Simpson University in Redding California where he specializes in microbiology and biotechnology. He also serves

as Science Advisor for the Focus for Health foundation.

Brian dedicated over 15 years as a bioengineer and the team leader for the High Throughput Biology Team and Operations Manager of the DOE Genomics: Genomes to Life (GTL) Center for Molecular and Cellular Systems at the Pacific Northwest National Laboratory (PNNL). Dr. Hooker managed applied plant and fungal molecular biology research projects at the Pacific Northwest National Laboratory, where systems biology researchers are focused on understanding gene and protein networks involved in individual cell signaling, communication between cells in communities, and cellular metabolic pathways.

### **Brian S. Hooker** **Keynote Speaker** **& Health Freedom Awardee**

In 1985, Dr. Hooker earned his Bachelor of Science degree in chemical engineering from California State Polytechnic University, Pomona, California. He earned his Masters of Science degree in 1988 and his doctorate in 1990, both in biochemical engineering, from Washington State University, in Pullman, Washington.

Brian Hooker has many accomplishments to his credit including: co-inventor for five patents, recipient of the Battelle Entrepreneurial Award in 2001, and a Federal Laboratory Consortium Recognition Award in 1999 for his work on “Reactive Transport in 3-Dimensions.” The breadth of Hooker's over 60 science and engineering papers have been published in internationally recognized, peer reviewed journals.

He has a 17-year-old son with autism and has been active in the autism community since 2002. Brian has investigated and uncovered many instances of fraud and malfeasance in the CDC's vaccine safety program and most recently enabled exposure of blatant scientific misconduct through the CDC whistleblower Dr. William Thompson.

**BIOGRAPHY** Jim Jenks is an herbalist and runs Herbal Rose with his wife Linda on a small GREEN Ranch south of Reno in the Washoe Lake Valley. They proudly boast being one of the first zero-energy footprint businesses in the community. Jim holds a Bachelor of Science degree in Business Administration from Univ. of Ariz., a Chartered Herbalist degree from Dominion Herb College, a Certificate of Merit in Iridology from Dr. Bernard Jensen, and a Doctor of Herbal Medicine from American Medical College. He recently celebrated his 40<sup>th</sup> year in the Nutrition Education field. He has studied with numerous leading teachers and has authored several books and videos. He has lectured in almost every state, Canada, New Zealand, Australia and the U.K and has been on regional, national TV and radio interviews and lectured at numerous herb conventions. Jim and his wife have in-depth experience and expertise in balancing people with herbs and nutrition. Together they serve as a research center for hundreds of herb shops throughout the nation.

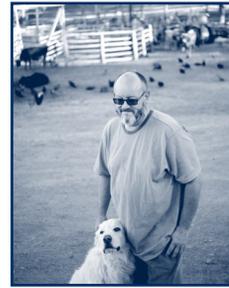


**Pete Kennedy, JD**  
**Farm-to-Consumer**  
**Legal Defense Fund**  
**Raw Milk Advocacy**

**AWARDED** "For his leadership and dedication in supporting raw milk advocates in numerous states, and acting as a central hub of information and support for the protection and promotion of access to raw milk products in the U.S. and in celebration of the impressive successes of access to raw milk in 2015, as Connecticut became the sixth state to pass legislation increasing access to raw milk."

**BIOGRAPHY** Pete Kennedy is an attorney in Sarasota, Florida and serves as president of the Farm-to-Consumer Legal Defense Fund. He has assisted and/or represented dairy farmers facing possible enforcement action in various states as well as helped others to get started in the business of distributing raw dairy products. Pete has also counseled on a variety of issues including the right to farm, on-farm poultry and meat processing, herdshares, buying club operations, and legislation at both the federal and state level. He is currently working to promote passage of the Raw Milk Freedom Act, the Interstate Milk Freedom Act and the PRIME (Processing Revival and Intrastate Meat Exemption) Act.

**Frank Wallace**  
**Wyoming Food Freedom**

**AWARDED** "Accepted by Frank Wallis 'for the many people who lobbied, made phone calls, sent emails, attended hearings, and testified over the period of many years in order to have the Wyoming Food Freedom Act enacted in our state.' NHFC congratulates Frank and his team for six years of rigorous work on the Wyoming Food Freedom Act (WFFA), passed into law on March 3, 2015, setting the bar high for efforts at similar legislation elsewhere in the United States of America. Under the WFFA, the production and sale within Wyoming of any food except meat products by a producer direct to the "informed end consumer" is not subject to licensing or inspection."

**BIOGRAPHY** Frank Wallis is a full time farmer in northern Wyoming. Born and raised on the family ranch, he returned to the ranch about a dozen years ago after spending a couple of decades in the corporate life and working in cities like Houston, Phoenix and Denver. His company, EZ Rocking Ranch, has been marketing local foods in the Gillette, Sheridan, and Buffalo area for over 10 years through farmers markets and direct sales. Frank is involved in helping develop local food systems to help regenerate rural economies in Wyoming and other states. Frank has been invited to speak at various events including recently testifying before the Montana Legislature regarding developing raw milk access and at Wyoming gatherings of local food lovers. He was a panelist at the Food Freedom Fest in Virginia this fall to help the local food movement spread nationwide. The Wyoming Food Freedom Act which became law this spring was a major success for the local food movement and one of his main goals is to continue to the development of local foods in not only Wyoming, but across the country. He is a member of the Weston A. Price Foundation, an organization promoting nutrient dense foods and the Farm-to-Consumer Legal Defense Fund whose mission is defending the rights and broadening the freedoms of family farms and protecting consumer access to local foods.

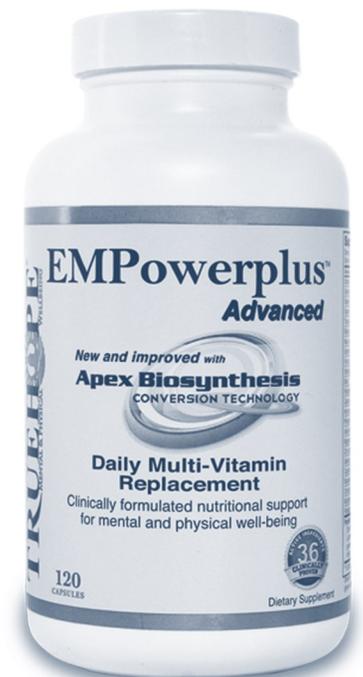
