Attend Lobby Day to Protect Vaccine Exemption Rights in MN on March 22- RSVP Today!

Minnesota legislators need to hear from YOU to know we're still watching HF 393/SF 380 Vaccine Exemption Modification bill! Join us to create a large physical presence that will keep the opposition strong around this issue in 2016. [RSVP Here](#), or just show up, to thank our legislative supporters and to educate the undecided about why opposing HF393/SF 380 is the right thing to do.

As you may have heard, the proposed bill to restrict vaccine exemptions in Minnesota did NOT pass in 2015. However, the bills are still alive and they could be revived and passed in 2016. **Please attend the upcoming event (details [here](#)) to help us protect MN exemption rights!** [SF380](#) passed the Senate Health Committee 6:4 (1 abstain) but no vote took place on the Senate floor so it did not advance. [HF393](#) did not receive a hearing in the House Health Committee.

What we need you to do:

2. Call to make an appointment with your legislators for Tuesday, March 22, between 9:30-4pm. If you don't know who represents you, you can look up your personal legislators [here](#).

-Tell the office you are a constituent, that you'll be participating in a lobby day hosted by a coalition of organizations supporting MN vaccine exemption rights, and that you'd like to bring one or more additional lobby day participants with you.

-They might give you 5 minutes with the Legislative Assistant, tell you to attend a meeting set-up by another lobby day participant, or tell you to find your legislator outside of a committee meeting room at a certain time; happily take whatever they offer you (and email atatenner@gmail.com with your appointment information).

3. Show up on 3/22 to let us help you lobby your legislators and provide materials asking them to Oppose SF380/HF393, obstructing vaccine choice.

-The day will begin with introductory remarks from several leaders driving this opposition followed by a brief Lobbying 101 training, before we break into small groups. Everyone is encouraged to visit with their personal legislators and to also attend meetings with members of the House Health Committee that will be set-up by the lobby day planning committee.

Come for as long as you are able. Simply showing up makes them notice how important this issue is to Minnesota citizens and to our health freedoms overall. Children are welcome.

What the bill does:

SF380/HF393 eliminates the current conscientious belief exemption to vaccination for school children in Minnesota and replaces it with a new personal belief exemption that must include a statement from a physician and must be on a form developed by the commissioner of health. This bill will make it more difficult for parents who wish to decline vaccines, use a different schedule for vaccines than the recommended one, or who wish to skip one of the vaccines, or more, to get an exemption. Parents will be required to schedule a visit with a physician who will give them a presentation on CDC vaccination perspectives.

Changes to SF 380 Since Introduction:

SF 380 had a hearing in the Health, Human Services and Housing Committee, and passed on a vote of 6 – 4 with one abstention. Senator Eaton, author of SF 380, offered a “Delete-all” amendment, and the new version of the bill is even worse in the following ways:

- **This bill now requires parents to write a statement of why they choose not to have their child receive a vaccine and to have that statement recorded in the child’s medical record**
- **This bill raises questions of data privacy for those parents who choose exemptions Amendments to improve parental informed consent, and protect physician independence, were rejected**
- **This bill still allows a physician to refuse to sign the certificate, which could lead to “doctor-shopping” and, therefore, increased costs and coercion for parents**
- **This bill may have negative repercussions on physicians who sign certificates for patients requesting exemptions**
